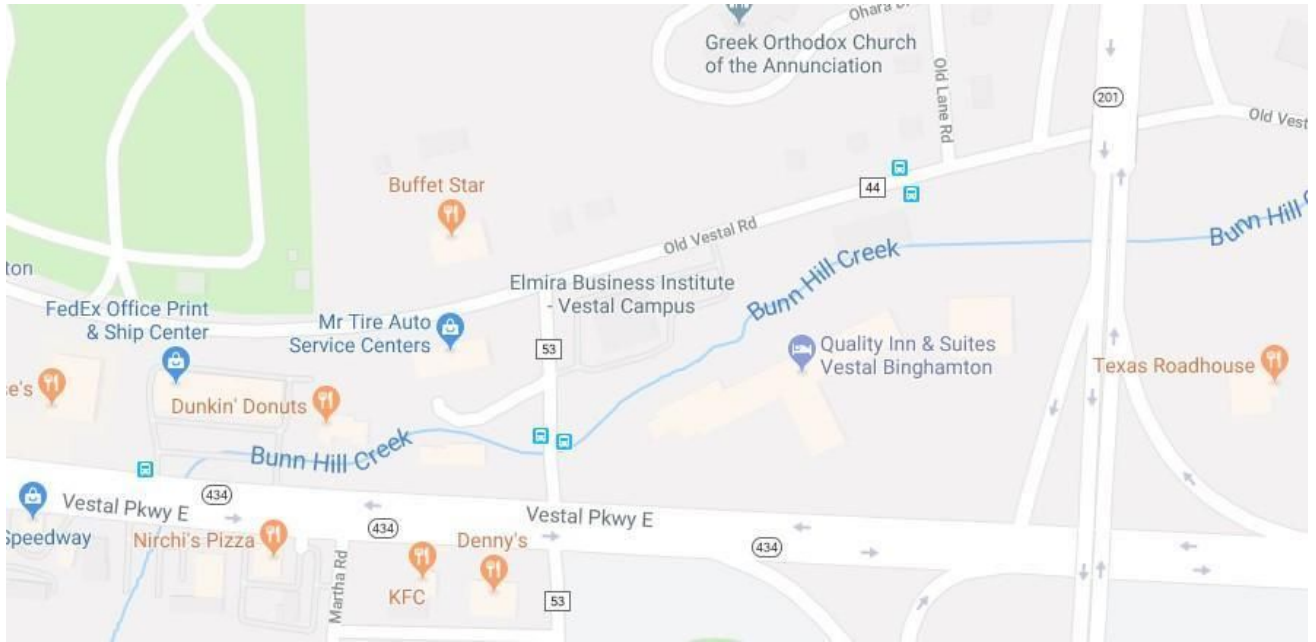
ASR Assembly and Preparation

Information in this report is provided to you as part of Elmira Business Institutes requirement under the The Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act ("Clery Act") and The Higher Education Act of 1965 (HEA). This report includes statistics for the previous three years concerning reported crimes that occurred on campus, off campus and adjacent public property. Alongside this, it provides information on institutional policies, procedures, and educational offerings to ensure a safe campus.

Elmira Business Institute prepares this report with support from institutional CSAs, Title IX Coordinator, Vestal Police Department, New York State Police and the Broome County Sheriff's Department. Each year, by October 1st, an email notification is sent to all enrolled students, faculty and staff. This notification provides information on how to access the Annual Security Report online and any relevant changes to safety and security policies.

Campus Geography

Elmira Business is located at 4100 Vestal Road, Vestal, NY in an executive corporate park. There is no public property on the premise of EBI, there are parking lots on "campus." EBI rents its location and while having control over the day to day space, any physical enhancements or upgrades are vetted and approved by the property owner before implemented.

Security Authority

EBI Vestal Campus employs administrative staff for security. Security officers do hourly patrols of the inside premises of Elmira Business Institutions Vestal location. These officers, while providing basic security services, are to report any safety concerns to local law enforcement. Security officers are not armed personnel.

Campus Security Authorities

The Clery Act requires Elmira Business Institute to provide an annual safety and security report. In addition to input from law enforcement, certain staff positions are designated as Campus Security Authorities (CSA) for the purpose of providing information for this report. CSAs are usually found in departments responsible for, but not limited to, student and campus activities, safety/security, discipline, housing, athletics, human resources or judicial proceedings. This designation also includes any individual who has been specified by EBI to receive and report offenses.

CSA's are responsible for reporting the number of crimes and incidents as described in the Clery Act that occur in their department to the Vestal Police Department. EBI has designated the following staff as CSAs for their Vestal location:

Law Enforcement Authority

Elmira Business Institute is located in the town of Vestal New York in the County of Broome. Vestal Police Department is the local law enforcement authority who shares joint jurisdiction with the Broome County Sheriff's Office and The New York State Police. As the local authority, Vestal Police Department provides initial response to any calls for assistance. EBI students are

aware of local law enforcement and understand they can report a crime to any agency listed above.

Campus Access and Security Policies

EBI Vestal Campus is a one building facility with two entrances. One at the main entrance at the rear of the building, which is staffed with a receptionist. The second entrance is on the upper level where they are directed to the main entrance of the building. All students, staff and faculty are required to wear their identification badges always. Visitors check-in at the front reception area and are announced to the appropriate party they are meeting with

Campus Safety Programs

EBI Vestal campus hosts several personal safety events on campus each year. The topics range from alcohol and drug education, to sexual violence awareness, to personal and dating safety. EBI has partnered with local law enforcement and community partners to provide these programs.

Alcohol and Drug Information

EBI Vestal is compliant with all requirements of the Drug Free Schools and Communities Act (Edgar Part 86). An annual notification is sent to all members of the community alerting them to policies pertaining to alcohol and substance abuse and institutional expectations of students and employees. Sexual Violence Policy

EBI Vestal has an extensive Sexual Violence policy that can be found in the Institutions [Code of Conduct](#) as well as [online](#). Our policy is in line with New York State 129-B (Enough is Enough), Title IX and The VAWA amendments to the Clery Act.

Reporting an incident of Sexual Violence

Any Elmira Business Institute student, staff member, or faculty member who has been the victim of sexual misconduct is encouraged to seek support and assistance from within or outside the Institution. Incidents of sexual misconduct that happen on EBI property or between students, staff, or faculty should be reported to the appropriate campus Title IX Coordinator. Reporting a sexual offense quickly is important to preserving evidence that may be necessary to prove the offense occurred. Elmira Business Institute employees who become aware that a student has been a victim of sexual misconduct including sexual harassment or assault, domestic or dating violence, or stalking are encouraged to report these incidents to the Campuses Title IX Coordinator.

While certain employees may also have a reporting obligation, if a complaint is made to anyone other than the Responsible Administrators listed above, the complainant risks the possibility that it will not come to the attention of the proper officials and may, therefore, not be acted upon. For purposes of this policy, Faculty are not considered Responsible Administrators. In addition, unless a report is made to someone listed as a Confidential Resource, confidentiality cannot be assured.

Upon receiving a report, the Responsible Administrator to whom the report is made will discuss with the complainant available avenues and options. Options may include conduct action against the accused and remedial actions to correct the effects of the Misconduct.

Elmira Business Institute will review the facts and circumstances of each case, as well the complainant's wishes, in deciding whether and what steps are reasonable and appropriate. A Responsible Administrator will share all information reported to him/her with the Title IX Coordinator and may share with other school administrators, as needed. A Responsible Administrator will similarly report Misconduct that he or she observes firsthand or learns about in any other manner.

Confidential Resources Elmira Business Institute is a non-traditional higher education institution. With that being said, EBI has designated a Confidential Resource at each campus. [Timely Warnings](#)

In accordance with the Jeanne Clery Crime Disclosure Act, Timely warnings are issued when an imminent threat to the health and safety of the EBI community exists. The Senior Vice President is the primary person authorized to send these warnings. In her absence, in order to prevent delay, the Administration is authorized to make the notification. Elmira Business Institute will provide as much detail as possible in issuing a timely warning. At the request of law enforcement, EBI may delay on issuing a timely warning if the information released may jeopardize an ongoing criminal investigation or create a more dangerous situation for the health and safety of the campus community.

An "Emergency Notification" will be sent to the community when there is a potential concern for the safety of the EBI community. This may include but is not limited to police activity in the area, weather emergencies, criminal issues, ongoing patterns of criminal behavior or other concerning issues deemed appropriate by the Senior Vice President.
