CONSUMER INFORMATION

- How the standards of academic progress (SAP) impact financial aid eligibility and re-establishing financial aid when a student fails to meet SAP This information is provided on pages 14-15 and 31-39 of the Catalog.
- Names of associations, agencies, and/or governmental bodies that accredit, approve or license the College and its programs - This information is provided on pages 6 of the Catalog. A student may request a copy of the College's accreditation, licensure, or approval by submitting a written request to the Senior Vice President's office.
- Special facilities and services available to disabled students Students should discuss these issues with their Admissions Representative upon application for admission to the College. The Admissions Representative will provide the student with services available for the student's particular needs.
- Withdrawal procedures This information is provided on page 24-26, as well as 41 of the Catalog.
- Refund policies For all withdrawn students receiving federal student aid, colleges are required to determine the

 calculate tuition charges assessed for the period attended in accordance with our refund policy.

FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT (FERPA)

The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99) is a federal law that protects the privacy of student education records. The law applies to all schools that receive funds under an applicable program of the U.S. Department of Education.

FERPA gives parents certain rights with respect to their children's education records. These rights transfer to the student when he or she reaches the age of 18 or attends a school beyond the high-school level. Students to whom the rights have transferred are "eligible students."

- Parents or eligible students have the right to inspect and review the student's education records maintained by the school. Schools are not required to provide copies of records unless, for reasons of great distance, it is impossible for parents or eligible students to review the records. Schools may charge a fee for copies.
- Parents or eligible students have the right to request that a school correct records which they believe to be inaccurate or misleading. If the school decides not to amend the record, the parent or eligible student then has the right to a formal hearing. After the hearing, if the school still decides not to amend the record, the parent or eligible student has the right to place a statement with the record setting forth his or her view about the contested information.
- Generally, schools must have written permission from the parent or eligible student in order to release any information from a student's education record. However, FERPA allows schools to disclose those records, without consent, to the following parties or under the following conditions (34 CFR §99.31):
 - o School officials with legitimate educational interest,
 - Other schools to which a student is transferring,
 - Specified officials for audit or evaluation purposes,
 - Appropriate parties in connection with financial aid to a student,
 - o Organizations conducting certain studies for or on behalf of the school,
 - Accrediting organizations,
 - To comply with a judicial order for lawfully issued subpoena,
 - Appropriate officials in cases of health and safety emergencies, and
 - State and local authorities, within a juvenile system, pursuant to specific State law.

Schools may disclose, without consent, "directory" information, such as a student's name, address, telephone, date and place of birth, honors and awards, and dates of attendance. However, schools must tell parents and eligible students about directory information and allow parents and eligible students a reasonable amount of time to request that the school not disclose directory information about them. Schools must notify parents and eligible students annually of their rights under FERPA. The actual means of notification (special letter, inclusion in a student bulletin, student handbook, or newspaper article) is left to the discretion of each school.
